III Notifications:

Notifications issued to the Escrow Agent: 383.

- The total amount awarded to United States Parties and notified to the Escrow Agent to date: US\$2,166,998,515.43 and the US Dollar equivalent of £303,196.00, DM 297,051.00 and Rls. 97,132,598 (excluding any interest to be calculated by the Escrow Agent). Of that amount, US\$1,665,366,959.76 and the US Dollar equivalent of £303,196.00 and DM 297,051.00 was by Awards on Agreed Terms and Partial Awards on Agreed Terms.

Notes: (a) A total amount (excluding any interest to be calculated) of US\$1,013,716,179.13 and the US Dollar equivalent of Rls. 7,977,343 was awarded or ordered to be paid to Iran and Iranian parties but was not notified to the Escrow Agent as it was not payable from the Security Account. This amount includes the amounts of US\$454,390,207.71, US\$37,900,000.00, US\$16,148,022.29 and US\$134,128.56, as awarded in Award No. 306-A15(I:G)-FT², and an amount of US\$478,301,970.27 and the US Dollar equivalent of Rls. 423,911 were awarded by Awards on Agreed Terms.

(b) By Order filed on 21 September 1990 in Case No. B1 (Claims 2 & 3), the Tribunal terminated arbitral proceedings insofar as they related to a request by Iran for an interim measure and attached a settlement agreement dated 10 September 1990 pursuant to which the United States was obligated to pay US\$200,000,000.00 into the Security Account established pursuant to paragraph 7 of the Declaration of the Government of the Democratic and Popular Republic of Algeria dated 19 January 1981.
